MINUTES OF THE MEETING OF DELHI DISASTER MANAGEMENT AUTHORITY (DDMA) HELD THROUGH VIDEO CONFERENCING ON 18.06.2020 AT 11.00 AM UNDER THE CHAIRMANSHIP OF HON'BLE LT. GOVERNOR/ CHAIRPERSON, DDMA.

- A meeting of the Delhi Disaster Management Authority was held on June 18, 2020 through Video Conferencing under the Chairmanship of Hon'ble Lt. Governor to review Health preparedness in the wake of ongoing pandemic of COVID-19. List of participants is enclosed. Dr. Randeep Guleria Director, AIIMS also attended as a special invitee.
- 2. At the outset, Chairperson welcomed the participants. Thereafter Shri Sanjeev Khirwar, Principal Secretary (Revenue)/Member Secretary, DDMA briefed the participants about the agenda for the meeting. The members deliberated upon the same.
- 3. Regarding the agenda of fixing the rate for the COVID RT PCR Test, convenor, DDMA apprised the participants about the report submitted by Shri Paul, Member, NITI Aayog, which has recommended fixing the rates at Rs.2400/- for each COVID RT PCR Test for the samples collected by the Government, The labs should also ensure adherence to quality, patient feedback and grievance redressal system for the test takers in case of any shortcoming. The members discussed the same and some of the members desired that uniform rates be fixed irrespective of private or Government collected samples. After detailed deliberations DDMA accepted the recommendations of committee headed by the Member, NITI Aayog with the condition that the rate recommended would be the maximum chargeable for specimens collected by any facility whether in govt. or private.
- 4. Further, Member Secretary, DDMA apprised the participants about the commencement of the Antigen Detection Test with effect from today at about 169 locations with 341 teams. He informed that the ICMR conducted training for the concerned Health Professionals. All social distancing norms will be followed at the centres and the Medical teams at the centres will ensure that in case anyone is found positive then the guidelines and protocol issued by the ICMR will be followed for treatment.
- 5. The Members, thereafter, approved the Format to be issued by Hospitals for the patients who have recovered from COVID19.Members also approved the Format to be issued to the persons being tested for antigen w.e.f. June 18, 2020 at various centres subject to approval by Director, AIIMS & DG, ICMR.
- 6. Lastly, the following Orders issued since last DDMA meeting held on June 09, 2020 were ratified.
