MINUTES OF THE MEETING OF DELHI DISASTER MANAGEMENT AUTHORITY (DDMA) UNDER THE CHAIRMANSHIP OF HON'BLE LT. GOVERNOR/ CHAIRPERSON, DDMA HELD ON 20.06.2020.

- A meeting of the Delhi Disaster Management Authority was held on June 20, 2020 through Video Conferencing under the Chairmanship of Hon'ble Lt. Governor to review Health preparedness in the wake of ongoing pandemic of COVID-19. List of participants is enclosed.
- 2. At the outset, Chairperson welcomed the participants. Thereafter, the Principal Secretary (Revenue)/Member Convener, DDMA briefed the participants about the agenda for the meeting. The members deliberated upon the agenda items.
- 3. After initial deliberations, it was felt necessary that it would be better, if the members of the Committee constituted on the direction of the MHA to fix rates for care of patients in private hospitals may also join the discussion to make informed decisions. Hence, the meeting was deferred to 05.00 p.m.
- The meeting resumed at 05.00 p.m. Dr.V.K. Paul, Member, NITI AAYOG and Dr. Balram Bhargava, DG ICMR also participated. The members deliberated on the agenda points in detail.
- 5. The following was discussed and decided:
 - i. Regarding the agenda of fixing price ceiling for treatment of COVID-19 patients by the private hospitals, the members discussed the same and unanimously resolved to accept the recommendation of the Committee headed by Sh. V.K. Paul, Member, NITI AAYOG with the proviso that all COVID Beds would be charged as per rates given by the Committee subject to upper limit of 60% of the total hospital bed capacity.
 - With regard to ratification of two orders issued by the Chairperson of SEC/ DDMA, the following was deliberated and decided;
 - a) The first order dated 18.06.2020 issued by Chairman SEC/DDMA relating to involvement of NGOs and others for survey was ratified.
 - b). With regard to order No. F. No. 1(461)/ DDMA (HQ)/MISC/Covid-19/2020/700-708 dated 19.06.2020, issued by Hon'ble Lt. Governor as Chairperson DDMA u/s 18 (3) of Disaster Management Act, it was decided that Clause 4 (iii) of the order would be substituted by the following. "All individuals who are positive will be referred to the COVID care centres for assessment of clinical conditions, severity of illness and presence of comorbidities. Simultaneously, physical assessment will also be done whether adequate facilities for home isolation like minimum two rooms and separate toilet exists so that the family members and neighbors are protected and a cluster of cases does not develop in that locality.

If adequate facility for home isolation exists, and the person on clinical assessment is found to have no co-morbidities and does not require hospitalization, he would be offered to either continue to stay in COVID centre/paid isolation facility (hotels etc), or can opt for home isolation. Rest of the people will have to continue to stay in COVID care centres as per the guidelines of MoHFW.

Those who are in home isolation should follow home isolation guidelines laid down by the Ministry of Health and Family Welfare and should stay in touch with health care providers so that if their condition deteriorates, they can be moved to the COVID hospitals.'
