ORDER No. 122-A

Whereas the Government of NCT of Delhi has issued the Delhi Epidemic Diseases, COVID-19 Regulations, 2020 under the Epidemic Diseases Act, 1897 for prevention and containment of COVID-19.

And Whereas the Govt. of NCT of Delhi in exercise of the aforesaid powers has notified a **lockdown** in the whole of territorial jurisdiction of NCT of Delhi from 0600 hrs on Monday, 23rd March, 2020.

Whereas it is imperative to <u>strictly observe the lockdown and isolation measures</u> to contain the spread of COVID-19 in NCT of Delhi.

Now Therefore, in exercise of the powers, conferred under Section 22 of the Disaster Management Act, the undersigned, in his capacity as Chairperson, State Executive Committee GNCTD, hereby issues the following directions for their strict implementation. This Order shall remain in force, in all parts of Delhi till the midnight of 14th April, 2020.

- 1. No Bus, whether run by DTC or under Cluster operations, shall ferry any passenger(s) who does not have any Government I-card/ authorized pass issued by the designated authority as mandated vide Order No. F.51/DGHS/PH-IV/COVID-19/2020/prsecyhfw/3331-45 dated 24.03.2020 (Annexure-I) and subsequent order No. 121 dated 25.03.2020 (Annexure-II) and Addendum issued vide Order No. 122 dated 26.02.2020 (Annexure-III).
- 2. In case any unauthorized passenger(s) is found to be ferried by any DTC/Cluster bus, strict criminal action viz. FIR u/s 188 of IPC shall be lodged against the concerned DTC employees (Conductor, Driver, Depot Manager) or Cluster employees (Conductor, Driver, Depot Manager) as the case maybe.

- 3. All the District Magistrates & District Deputy Commissioners of Police, Incident Commanders & counterpart Assistant Commissioners of Police and SHOs of respective jurisdiction shall remain in the field for enforcing the aforesaid orders.
- 4. Delhi Police shall ensure complete sealing and manning of all inter-state borders and allow the movement of only those personnel and transportation exempted under the aforesaid Order No. 121 dated 25.03.2020 (Annexure-II) and subsequent Addendum issued vide Order No. dated 26.03.2020 (Annexure-III).
- 5. Adequate number of pickets shall be established by Delhi Poice to enforce the aforesaid Lockdown Orders.
- 6. District Magistrates shall ensure adequate availability of temporary shelter homes and food arrangements for homeless/migrant labour stranded due to lockdown measures in their respective areas. In this regard, Chairman, NDMC/Commissioners (SDMC/EDMC/North DMC)/CEO, Delhi Cantonment Board are directed to provide all help and assistance to the respective District Magistrates.
- 7. Further, District Magistrates are empowered to requisition the personnel of aforesaid Urban Local Bodies in consultation with their respective HoDs for effective compliance of above instructions and aforesaid Lockdown Orders.
- 8. The migrant people, who have moved out to reach their home state/home towns, must be kept in the nearest shelter or quarantine facilities after proper screening for a minimum period of 14 days as per the standard health protocol.
- 9. All the employers, be it in the Industry or in the shops and commercial establishments, shall make payment of wages of their workers, on the due date, without any deduction, for the period their establishments are under closure during the lockdown. For this purpose, not more than two persons (including employer and/or accounts-related employees) shall be issued identification and vehicular pass for the day earmarked for the payment of salary in usual course of business and the day before. The employees shall either be credited the salary/wages in their respective bank accounts or be paid at their residence.

- 10. Wherever the workers, including the migrants, are living in rented accommodation, the landlords of those properties shall not demand payment of rent for a period of one month.
- 11. If any landlord is forcing labourers and students to vacate their premises, they shall be liable for action under the Act.

The District Magistrates & District Deputy Commissioners of Police, Incident Commanders & counterpart Assistant Commissioners of Police and SHOs of respective jurisdiction will be personally liable for implementation of the above directions and lockdown measures issued under the aforesaid Orders as enclosed.
