ORDER No. 122-B

Whereas, in exercise of the powers, conferred under Section 22 of the Disaster Management Act, the undersigned, in his capacity as Chairperson, State Executive Committee GNCTD, hereby issued Order No. 121 dated 25.03.2020 and guidelines, as per the Annexure, to the Departments of Government of NCT of Delhi, with the direction for their strict implementation.

And Whereas, a further order order no. 122 dated 26.03.2020 was issued in continuation by, the undersigned, along with an Addendum to the guidelines annexed to the aforesaid order No. 121, to the Departments of Govt. of NCT of Delhi, with the directions for their strict implementation.

And Whereas a further Order No. 122-A dated 29.03.2020 was issued for strictly enforcing lockdown measures and to provide relief to poor and needy persons including migrant labourers stranded due to lockdown measures.

Now Therefore, in exercise of the powers, conferred under Section 22 of the Disaster Management Act, the undersigned, in his capacity as Chairperson, State Executive Committee GNCTD, hereby issues the following directions for their strict implementation. This Order shall remain in force, in all parts of Delhi till the midnight of 14th April, 2020.

- A. Addition of sub clause (g) & (h) in exceptions to Clause 2
 - g. Agencies engaged in procurement of agriculture products, including MSP operations.
 - h. 'Mandis' operated by the Agriculture Produce Market Committee or as notified by the State Government.
- B. Sub-clause (a) in exceptions to Clause 4 includes shops of fertilizers.
- C. Addition of sub clause (l) & (m) in exceptions to Clause 4:
 - 1. Farming operations by farmers and farm workers in the field.
 - m. 'Custom Hiring Centers (CHC)' related to farm machinery.
- D. Addition of SubClause (e) in exceptions to Clause 5
 - e. Manufacturing and packaging units of Fertilisers, Pesticides and Seeds.
- E. Addition of Sub Clause (e) in exceptions to Clause 6
 - e. Intra and inter-state movement of harvesting and sowing related machines like combined harvester and other agriculture/horticulture implements.

The following is also clarified in the aforesaid orders:

a. With the issue of 1st addendum, transportation of all goods, without distinction of essential and non-essential have been allowed.

- b. 'Pension' under exemptions to clause 2(g), include pension and provident fund services provided by Employees Provident Fund Organisation (EPFO).
- c. Services of Indian Red Cross Society are also included under clause 3.
- d. Groceries include hygiene products such as hand washes, soaps, disinfectants, body wash, shampoos, surface cleaners, detergents and tissue papers, toothpaste / oral care, sanitary pads and diapers, battery cells, chargers etc.
- e. Entire supply chain of milk collection and distribution, including its packaging material is allowed.
- f. News paper delivery supply chain is also allowed under print media.

In addition to the above, the Central Government has also allowed use of SDRF for homeless people, including migrant labourers, stranded due to lockdown measures, and sheltered in the relief camps and other places for providing them food etc., for the containment of spread of Covid-19 virus in the country.

Also, a further Order No. 122-A dated 29.03.2020 was issued for strict implementation of additional measures to stop the movement of migrants and providing them with quarantine facilities, shelters, food etc., and ensuring payment of wages and non-eviction by their landlords. Its strict implementation needs to be ensured.
