**ORDER - 120**

Whereas the Govt. of NCT of Delhi has notified a lockdown in the whole of territorial jurisdiction of NCT of Delhi from 0600 hrs on Monday, 23rd March, 2020 to midnight of Tuesday, 31<sup>st</sup> March, 2020 vide order dated 22.03.2020.

And Whereas there may be certain homeless/destitute/deprived or distressed members of the society who may not have any means to access cooked food. Now, Therefore, in order to ensure regular access to cooked food to such homeless /destitute/deprived or distressed members of the society, under the provisions of Section 22 of the Disaster Management Act, 2005, the following measures shall be undertaken with immediate effect:

1. A Hunger Helpline between 1100 hours to 1500 hours and 1800 hours to 2100 hours shall be operational in the Control Rooms set up in all the offices of District Magistrates in NCT of Delhi. The helpline numbers of each district are enclosed in Annexure-I.
2. The Control Room, for this purpose, shall be manned by an officer of DUSIB to be nominated by CEO, DUSIB.
3. The helpline shall guide and assist all such persons to the nearest Night Shelter managed by DUSIB for accessing cooked meal.
4. The protocol related to social distancing and other measures as applicable in view of COVID-19 shall be strictly followed at the time of service of food in these Night Shelters.
5. Necessary security arrangements at the Night Shelters shall be provided by the respective District Deputy Commissioners of Police.
6. Sanitary arrangements at the Night Shelters shall be ensured by respective Municipal Corporations.
7. A Nodal Officer shall be appointed in each district by the respective District Magistrate to ensure smooth functioning and implementation of these measures.

Further, for proper co-ordination of efforts and also for effective implementation of the measures taken by the Government, an Advisory Panel under the Chairpersonship of Hon'ble Dy. Chief Minister and comprising of following members, is set up with the approval of Hon'ble CM, as per details below:-
