ORDER

Whereas, Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organisation and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi;

And whereas, Delhi Disaster Management Authority has issued various orders/ instructions from time to time to all concerned authorities to take all required measures to appropriately deal with the situation;

And whereas, in pursuance to orders no. DDMA/COVID/2020/1/14 dated 02.04.2020 and DDMA/COVID/2020/1/23 dated 04.04.2020, the District Magistrates have made necessary arrangements for supply of cooked food twice a day to needy people, including the migrant labours in such of the Government Schools in NCT of Delhi i.e., the Schools of Directorate of Education as well as NDMC and respective Municipal Corporations through the respective agencies, based on the joint assessment of District Magistrate and District Dy. Commissioner of Police concerned;

And whereas, it has come to notice that some districts may not have adequate number of Government Schools left at desired locations for providing food to the poor and needy;

Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, Govt. of NCT of Delhi, hereby directs that in case of paucity of suitable schools in any area, the District Magistrates may set up Food Shelters at alternate locations like Private Schools, Community Centres, Basti Vikas Kendras, etc., after joint assessment with the counterpart DCP. While it would be preferable that such premises are Government buildings, however, in case of exigency and non-availability of the Government building, private premises can also be used as Food Centre, following due procedure. However, it must be ensured that the person In-charge of the Food Centre is a Government Official of appropriate seniority. Other conditions as mentioned in order no. DDMA/COVID/2020/1/14 dated 02.04.2020 and subsequent order no. DDMA/COVID/2020/1/23 dated 04.04.2020 shall remain unchanged.
