

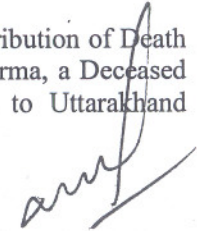

**Sub: Regarding Correction in Father's Name in respect of Sh. Yash Sharma s/o Sh. Chander Mohan Sharma in Death Certificate ( DL-51/2013) issued in respect of missing persons of Delhi who died in Uttarkahand Disaster and Distribution of Death Certificate and disbursement of Compensation Amount in respect of Sh. Yash Sharma**

With reference to your letter No. 9/U.K. Dis/SDM/Y.V./2014 dated 3/04/2014 vide which a death certificate in original in respect of Sh. Yash Sharma s/o Sh. Chander Mohan Sharma had been forwarded to this office for correction in the father's name of deceased. In this regard, I am to forward herewith the Death Certificate No. DL-51 dated 28/05/2014 as received from Government of Uttarakhand after desired correction in the death certificate for onward distribution to next of kin / relative of deceased persons by following the guidelines/ directions as have already been issued vide letter No. F. 1(27)/DDMA (HQ)/LMPU/PF-1/2013/06 dated 06.01.2014 and by Public Notice F. 1(27)/DDMA (HQ)/LMPU/PF-1/2013/31 dated 23.01.2014. It is, also, ensured that objections/ claims which have been raised / received have been disposed off before issuing these death certificates to next of kin/ relative of deceased persons.

Further, as compensation amount of Rs. 3.5 lakh in respect of the deceased person has been received by this department from Uttarakhand Government, the concerned SDM is directed to take up the case regarding release/ disbursement of compensation amount in prescribed format with the Deputy Controller of Accounts of Revenue Department ( H.Q.) as per letter No.F. 1(68)/DDMA(HQ)/Cheque/Uttarakhand/2013/737-42 dated 11.4.14.

The concerned SDM is also directed to furnish a certificate regarding Distribution of Death Certificate and disbursement of Compensation Amount in respect of Sh. Yash Sharma, a Deceased Person in Uttarakhand Disaster to DDMA Branch for onward submission to Uttarakhand Government.

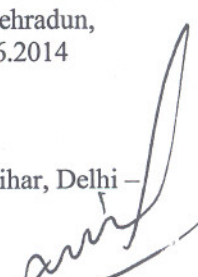
