ORDER

Whereas, the Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organisation, and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi;


And whereas, Delhi Disaster Management Authority has issued various orders/ instructions from time to time to all authorities concerned to take all required measures to appropriately deal with the situation;

And whereas, death of some inmates of Temporary Shelter Homes have been reported for non COVID-19 reasons.

Now therefore, all the District Magistrates and CDMOs are hereby directed to take immediate action on the following:

- i) All inmates staying in the Temporary Shelter Homes and Night Shelter Homes should be screened/ medically examined and those who are found sick and require medical assistance should be immediately admitted to non-COVID hospitals.
- ii) Those inmates who are found symptomatic/ suspect for COVID-19 should be shifted to COVID Care Centres, COVID Health Care Centres or dedicated COVID-19 hospitals, as the case may be.
- iii) A team of IHBAS should also examine each inmate staying in these Temporary Shelter Homes and Night Shelter Homes and counsel them properly. Those inmates who require further medical assistance should be shifted to IHBAS. The directions of Hon'ble Supreme Court in this regard, already communicated vide DDMA's orders dated 01.04.2020 & 02.04.2020 should be followed in letter and spirit.
- iv) The inmates requiring long time counseling/de-addiction support should be shifted to de-addiction centres run by Social Welfare Department.
- v) A medical team should regularly visit Temporary Shelter Homes and Night Shelter Homes to assess the health of the inmates.

This issues with the approval of Chief Secretary, Delhi.
