ORDER

Whereas, the Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organisation, and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi;

And whereas, Delhi Disaster Management Authority has issued various orders/instructions from time to time to all authorities concerned to take all required measures to appropriately deal with the situation;

And whereas, Delhi Disaster Management Authority (DDMA) has issued Order No.212 dated 01.06.2020, regarding extension of lockdown in containment zones in NCT of Delhi and guidelines for permissible and prohibited activities (in phased manner) w.e.f. 01.06.2020 in the areas of NCT of Delhi (outside containment zones). As per 'Annexure-A' attached with this order, Shops and Markets are in the list of permitted activities with specified restrictions. Further, vide order dated 01.07.2020, DDMA has ordered to extended lockdown in containment zones in NCT of Delhi up to 31.07.2020 or further order, and to maintain status quo with respect to activities which are allowed/prohibited in NCT of Delhi;

And whereas, the situation of COVID-19 in NCT of Delhi has been assessed and it has been decided that functioning of Rehari-Patriwallahs may be permitted with suitable restrictions, though opening of weekly bazaars may be prohibited.

Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, DDMA, Govt. of NCT of Delhi, hereby directs that the **Rehari-Patriwallahs** are allowed to function from 10 am to 8 pm daily, initially for a period of one week, in NCT of Delhi (except in containment zones), subject to compliance of all instructions/ guidelines issued by Govt of India / Govt. of NCT of Delhi to contain the spread of COVID-19, such as face covering, social distancing (2 gaz ki doori), hygiene practice etc. **However, weekly Bazaars in NCT of Delhi are not allowed till further order.** Further, those rehari-patri wallahs who fall under Special Surveillance Groups (SSGs) shall be screened & covered as per the Modified SoP for surveillance issued by DGHS, GNCTD vide order dated 08.07.2020, as amended from time to time.

All District Magistrates of Delhi, their counterparts District Dy. Commissioners of Police and all authorities concerned shall ensure strict implementation of these orders and take appropriate action against the offenders in case any offences are committed such as not wearing mask, not maintaining social distancing norms, spitting in public places etc. as authorised vide notification dated 13.06.2020 issue by Health & Family Welfare Department, GNCTD.

NOTIFICATION

Whereas, the COVID-19 outbreak has been notified as a "Disaster" for being a critical medical condition and pandemic situation under the "Disaster Management Act, 2005."

And whereas the Delhi Disaster Management Authority has issued detailed guidelines from time to time to contain the spread of COVID-19.

And whereas, instances have come to notice that above guidelines are not being followed in their letter and spirit.

And whereas, rising numbers of COVID-19 cases in NCT of Delhi warrant stricter compliance with the Various directives issued by the Central Government, and the Government of NCT of Delhi from time to time, pursuant to guidelines of National Disaster Management Authority and the Delhi Disaster Management Authority;

And whereas, to enforce these directives, it has now become imperative to impose penalties by way of fines for a deterrent effect;

Now, therefore, in exercise of the powers conferred under Section 2 of The Epidemic Disease Act, 1897 and also in view of the guidelines issued by Delhi Disaster Management Authority, Hon'ble Lt. Governor, Delhi is pleased to issue the following regulations:

- These regulations shall be called The Delhi Epidemic Diseases, (Management of COVID-19) Regulations, 2020.
- "Epidemic Disease" in these regulations shall mean COVID-19 (Corona Virus Disease 2019)
- 3 "Authorised Persons" under this Act shall and include
 - Secretary (Health & FW), GNCTD;
 - b. Director General Health Services (DGHS), GNCTD;
 - c. District Magistrate,
 - d. Chief District Medical Officer (CDMO),
 - e. Sub Divisional Magistrate (SDM) and District Surveillance Officer (DSO);
 - f. And such officers as may be authorized by Department of Health & Family Welfare, Government. of NCT of Delhi, District Magistrates and Zonal Deputy Commissioners of respective Municipal Corporations of Delhi;
 - g. And the officers of the rank of Sub Inspector and above of Delhi Police.
 - h. The above Authorized Persons shall be empowered to impose a fine of Rs. 500 for the first time and a further fine of Rs. 1000/- for the repeated offence, respectively for violating the directives/guidelines pertaining to the following:-

- a. Observation of quarantine rules.
- Maintaining of social distancing.
- Wearing of Face mask/cover in all public places /workplaces.
- d. Prohibition of spitting in public places.
- e. Prohibition on consumption of paan, gutka, tobacco etc in public places.
- 5. In case any person fails to pay the penalty on the spot, action under Section188 IPC shall be taken against him by the authorised police officer on receipt of a complaint from any Authorised Persons or on his own.
- 6. Protection to Authorized Persons under the Act: No legal suit or proceedings shall lie against the Authorized Persons for anything done or intended to be done in good faith for ensuring the stricter compliance under these regulations unless proved malafide/otherwise.
- 7. These regulations shall come into force immediately and shall remain valid for a period of one year from the date of publication of this notification.
