Dear Chief Secretary,

I am writing in continuation of my D.O. letter of even number dated 18th July 2020 and Ministry's letter of even number dated 8th July 2020 regarding compliance of Unlock-II guidelines and other issues relating to response to COVID-19 Pandemic.

- 2. As per the reports received in this Ministry, while efforts are being made by various State Governments to prevent large religious gatherings and other programmes, violation of guidelines have been observed during the course of certain religious congregations. Efforts to enlist the support of community leaders and o'her necessary action may kindly be taken to ensure compliance of the prevailing guidelines and national COVID-19 directives issued by MHA, as well as the SOP on religious places issued by the Ministry of Health and Family Welfare.
- 3. From certain areas, reports regarding lack of proper hygienic facilities in quarantine centres/ covid care centres continue to be received. It is imperative that we focus and review the matter so as to ensure the requisite facilities as also timely testing and discharge of those quarantined.
- 4. Protests/ resentment of healthcare professionals/ healthcare workers and other frontline workers on various issues continue to be received from certain States. The issue needs to be handled proactively and with sensitivity.
- 5. Supply of essential commodities and other issues causing resentment amongst the residents of containment zones have also been a challenge in some areas. These need to be addressed on priority and awareness may be generated amongst the residents of containment zones regarding the necessity of strict perimeter control. Regular meetings at field level with Resident Welfare Associations, Market Associations etc are necessary for reinforcing the importance of social distancing norms and compliance of national COVID-19 directives to check the spread of the pandemic.

- 6. I have already emphasized in my earlier letter regarding the need for strict and prompt action to check black-marketing of plasma and other drugs. Steps may also be taken to address the apprehension amongst public relating to shortages in this regard.
- 7. Migrant workers have started returning from their native places to their workplaces. It is extremely necessary that arrangements be made for conducting their medical check-up/ testing and addressing their healthcare needs to prevent any spurt in COVID-19 cases in their workplaces and residential areas.
- 8. There is pressure on health infrastructure in several areas. I would request you to closely review and monitor functioning of the control rooms set up in this regard and pay special attention to ensure coordination between agencies so that we can ensure proper ambulance services, streamline admission in hospitals etc.
- 9. According to the feedback we have received in the Ministry, industrial activity in some States continues to be hampered due to lack of demand for products, labour shortages and intermittent lockdowns. I would be grateful if you could review these aspects and work towards restoration of economic activities, while ensuring compliance with social distancing norms and health protocols.
