ORDER

Whereas, the Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization, and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi;

- 2. And whereas, Delhi Disaster Management Authority has issued Order No. 450 dated 10.07.2021 which inter-alia directs that all social / political / sports / entertainment / cultural / religious / festival related gatherings and congregations are prohibited and visitors are not allowed to religious places in NCT of Delhi;
- 3. And whereas, upcoming Kanwar Yatra-2021, will commence from 25.07.2021 and in spite of being banned / suspended by Uttarakhand Government, there is an apprehension of gatherings / congregations / processions during Kanwar Yatra-2021, therefore, in view of persisting COVID-19 situation, it is decided that Kanwar Yatra-2021 should not be permitted in order to prevent the spread of COVID-19 virus in the territory of NCT of Delhi.
- 4. Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, DDMA, Govt. of NCT of Delhi, hereby directs that no celebrations / processions / gatherings etc. shall be allowed during forthcoming Kanwar Yatra-2021 starting from 25.07.2021 in NCT of Delhi.
- 5. All District Magistrates of Delhi & their counterpart District Deputy Commissioners of Police and all other authorities concerned shall ensure strict compliance of this order and adequately inform and sensitize the field functionaries about these instructions for strict compliance, in letter and spirit.
- 6. In case any person is found violating the aforesaid instructions, the defaulting person(s) shall be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, Section 188 of IPC and other applicable laws.
