Whereas, the Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization, and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi;

And whereas, Delhi Disaster Management Authority has issued various orders/instructions from time to time to all authorities concerned to take all required measures to appropriately deal with the situation;

And whereas, in WP(C) No. 2983/2020 titled as SAMA- Resource Group for Women & Health Vs Union of India (UOI) & Ors., Hon'ble High Court of Delhi vide order dated 22.04.2020 has directed Govt. of NCT of Delhi to ensure that the helpline Number assisting the Senior Citizens in Delhi, shall also be made available for pregnant ladies. The helpline number shall be publicised adequately in the newspapers and social media as also through the Delhi Police, wherever possible. It is also directed to ensure that no barriers are faced by pregnant ladies and their family members residing in hot spots during the lockdown;

And whereas, DDMA vide Order No.115 dated 30.04.2020 has already issued directions that the helpline with number 1077 of Revenue Department, Govt. of NCT of Delhi shall also function as the helpline for Senior Citizens for COVID-19, on 24X7 basis;

Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, DDMA, GNCTD, in continuation of DDMA Order No. 115 dated 30.04.2020, hereby directs that the helpline with number 1077 of Revenue Department, Govt. of NCT of Delhi shall also function as the helpline for Pregnant Ladies. Dy. Commissioner (HQ), GNCTD shall be responsible for efficient functioning of helpline on 24X7 basis. Pr. Secretary (I&P), GNCTD and PRO, Delhi Police are directed to give adequate publicity of the said helpline number in newspapers and social media. All District Magistrates and their counterpart District Deputy Commissioners of Police shall ensure that no barriers are faced by pregnant ladies and their family members residing in hot spots during the lockdown.
