Sub:- Report on Disbursement of compensation amount to next of kin in respect of Deceased Persons in Uttarakhand Disaster and reasons for Non-Deliverance of Compensation Amount

Sir/Madam,

I am directed to invite your attention to the letter No. F.1(27)/DDMA(HQ)/ LMPU-PF-I/2013/163 dated 10.3.2014 and letter of even no dated 07.05.2014 vide which the Death certificates of Deceased Persons in Uttarakhand Disaster had been sent to you through concerned Dy. Commissioner for distribution to next of kin of deceased persons and it had also been requested to ensure that the cases of compensation amount of Rs. 3.5 lakh per deceased person are sent to DCA (H.Q.) for payment. Moreover, vide letter No. F.1(27)/DDMA(HQ)/ LMPU-PF-I/2013/243 dated 07.05.2014, a report on distribution of death certificates and disbursement of compensation amount has been sought.

But it has been observed that order has not been complied with so far in matter of disbursement of compensation and relatives of deceased persons are suffering due to non-deliverance of compensation amount. The Pr. Secretary-cum- Divisional Commissioner has viewed it seriously and desired that process of disbursement of compensation amount to next of kin in respect of deceased persons in Uttarakhand may be made immediately and a detailed report in regard may be submitted in following format by 27.05.2014




